SippOwisset Update - Arthur Gaines

Maureen reported on progress with the DEP case. COSH (Committee of SippOwisset Homeowners) had previously gotten a redesign of the proposed Sweeney house which addressed coastal bank issues. The outstanding DEP-related issue has been pollution of the pond. Sweeney has agreed to install a denitrifying system and this has been accepted by COSH.

Arthur reported on important new developments. A piece of property has been identified that is owned by the Langley brothers, the purchase of which would guarantee community access to the beach. Salt Pond Sanctuaries will actually acquire the property; a fund is being set up for this purpose.

Arthur recommended that we rescind the original \$5K-over-2-years vote of funds to COSH and target this money, instead, to the focused Salt Pond Sanctuaries fund.

Peter moved to rescind the \$5K-over-2-years donation to COSH that was approved in January. Kathy seconded. VOTED.

Arthur moved that we make a second contribution (..we have already made our annual contribution) to Salt Pond Sanctuaries both this year and next in the amount of \$2500 per year and that it be directed 'for acquisition of waterfront properties in SippOwisset'. Peter seconded. VOTED.
